

Parent/Guardian Consent Form and Media Release/Waiver

The purpose of this parent consent form is to both inform you and to request permission for your child's photo/image and personally identifiable information to appear in the media and/or be published on the district and/or school's web site.

As you are aware, there are potential dangers associated with the posting of personally identifiable information, including but not limited to your child's photo/image, on a web site since global access to the Internet does not allow us to control who may access such information. As you are also aware, there are also potential dangers associated with the appearance of your child's photo/image, or other personally identifiable information, in other print or telecast media. These dangers have always existed; however, **we as schools do want to celebrate your child and his/her work.** The law requires that we ask for your permission to use information about your child.

Pursuant to law, we will not release any personally identifiable information without prior written consent from you as parent or guardian. Personally identifiable information includes student names, photo or image, residential addresses, e-mail address, phone numbers and locations and times of class trips.

If you, as the parent or guardian, wish to rescind this agreement, you may do so at any time in writing by sending a letter to the principal of your child's school and such rescission will take effect upon receipt by the school.

- I/We GRANT permission, without fee, for this student's photo/image and name to be published on the school and/or district's public Internet site.
- I/We GRANT permission, without fee, for this student's photo/image and all other personal identifiers listed above to be published on the school and/or district's public Internet site.
- I/We DO NOT GRANT permission for photo/image that includes this student to be published on the school and or district's public Internet site.
- I/We GRANT permission, without fee, for this student's photo/image without any other personal identifiers to appear within newspapers, television, video broadcast, and other print or telecast media.
- I/We GRANT permission, without fee, for this student's photo/image and name to appear within newspapers, television, video broadcast, and other print or telecast media.
- I/We GRANT permission, without fee, for this student/s photo/image and all other personal identifiers listed above to appear within newspapers, television, video broadcast, and other print or telecast media.
- I/We DO NOT GRANT permission for a photo/image that includes this student to appear in newspapers, television, video broadcast, or other print or telecast media.

I agree to hold the Oradell Board of Education, its successors, assigns, employees, volunteers, sponsors, and representatives, both individually and collectively, completely harmless and faultless, from any claims or suits of any kind whatsoever, of or relating to the public display of my child's name, and if applicable, accompanying photograph; personally identifying information; and class trip information, on the school's website; school bulletin board; school Memory Book; school newsletter; school bulletins; on school promotion and media advertisement for school-sponsored activities, including but not limited to grade level projects; and in other print or telecast media, including but not limited to, newspapers, television, or video broadcast.
