Core Element #6 School-Level HIB Incident Reporting Procedure

- Revised Incident Reporting Forms are on school website
- Parent Form: Write a description, may be anonymous
- <u>Teacher Form:</u> Specific behavior(s) checklist, detailed description
- Student Form: Write a description, may be anonymous, and is more "kid-friendly"
- Investigation Report Form: Revised to include new information

Core Element #7 HIB Investigation Procedure

- District follows a flowchart that outlines the reporting procedure
- All information was reviewed with the staff
- The timeline is aligned with state regulations
- Parents always contacted in a timely manner
