Dear Parent/Guardian,

Since December 2017, eligible students in our K-2 Title I program received additional instruction prior to the start of the school day in the area of early literacy skills. Based on a parent survey, we received positive feedback on this program in areas including growth in early literacy skills and increased student interest in school. At this time, we are now able to provide a similar program to students in grades three and four, which will focus on providing multi-sensory instructional strategies and techniques in small group settings. I am writing to inform you that your child is eligible to receive additional instruction as part of this program!

This multi-sensory program for eligible third and fourth grade will begin on **Monday**, **April 23**, **2018**. Small group sessions focusing on multi-sensory instructional strategies will run each **Monday**, **Tuesday**, **Wednesday and Thursday from 7:55 am to 8:25 am, in accordance with the 17-18 School Calendar**. The program will run for **seven weeks** and will end on **Thursday**, **June 7**, **2018**. Students will enter through the Kindergarten doors on Church Street and should arrive by 7:55 a.m. so that instruction can begin promptly. Your child's Title I teacher or an administrator will be there to greet your child at the Kindergarten doors each day. The instructors for this program are Danielle DeLucia and Paige Majka.

Page two of this mailing includes an intent to participate form. Please inform us of your decision to have your child participate in this program by returning page two to your child's homeroom teacher as soon as possible. Once we receive confirmation of students who will be attending the program, we will then be able to organize sessions and assign teachers. After sections and teachers are determined, your child's Title I teacher will reach out to begin the line of communication.
